Type of Notice and Tender Stage	Tender Notice. Invitation to the single stage tender procedure (post-Qualification).
Project Measures	Works contractors may participate in procurement for one or more of the three work LOTs ("construction only" contracts) in five municipalities in rural Ajara. The works are predominantly the provision of buried water and sewer pipes and small buried tanks (pressure break tanks/reservoirs for water and septic tanks for wastewater). The works are divided into three LOTs (2A, 2B and 2C) with similar characteristics, other than the numbers of properties to be served and the associated variation in lengths of pipes and





	numbers of facilities to be installed. The project area is predominantly hilly/mountainous, with a low-density population bringing particular design challenges and is generally of high environmental value (i.e. virgin forest/landscape with high biodiversity).
Team Profile	Despite the terrain, the nature of the required works contractor(s) is deemed not to require special installation skills over, for example, an experienced works contractor in the installation of water and sanitation infrastructure in an urban area. However, the level of environmental and social impacts and risks of the project has been categorized as B, meaning applicants shall be required to demonstrate a defined level of Environmental Social Health and Safety (ESHS) capacity and experience. Based on the ESHS Requirements, the Works Contractor(s) shall be required to demonstrate experience of previous projects with high ESHS content.
Duration	The Project duration for all three LOTs consist on the following:
	 Construction period: 27 months (823 days), including winter breaks; Defect Notification Period: 12 months (365 days);
Procurement and Contract	For each of the LOTs a separate FIDIC pink book contract will be concluded.
	The procurement will follow KfW's procurement guidelines for single stage tendering. The selection of experienced Contractors is subject to the regulations contained in the "Guidelines for the Procurement of Consulting Services, Works, Plant, Goods and Non-Consulting Services in Financial Cooperation with Partner Countries" available at

	The single stage tender will be organized in a two-envelope format. The first envelope must contain the company qualification documentation as well as the Technical Proposal and all respective documents and declarations (according to ITB 11.1 (a)). The second envelope contains the Financial Bid (according to ITB 11.1 (b)). Financial bids will be opened only for companies that are qualified according to the eligibility criteria and pass the technical evaluation.
